2024 Western Snow & Ice Conference and National Snow Roadeo Celebrates Ten Years in Loveland!

The 44th annual Western Snow and Ice Conference and 38th National Snow Roadeo were held in Loveland for three days of beautiful September weather. The 2024 Western Snow and Ice Conference and National Roadeo set records for the highest attendance in its history. The conference had a record attendance of over 1,450 attendees. The National Snow Roadeo also saw record registrations, with both the Loader and Skidsteer competitions exceeding the 100 mark in registrants.

During the three days of the conference there were more than 48 speakers offering 46 educational sessions. The Winter Maintenance Supervisor Certificate Program had 110 professionals attend, with an additional 80 participants completing the Winter Maintenance Operators Certificate class. Again, this year, the exhibition hall was sold out with 105 inside exhibitors displaying equipment, products, and services inside the Embassy Suites, and all but one space was sold outside for the display of plows, sweepers, loaders and much more equipment.



A very special thank you to our major sponsors, sponsors of the Coffee and Snack Breaks, National Snow Roadeo Water, as well as our Winter Maintenance Supervisor Certificate Workshop sponsors. Once again 4Rivers Equipment sponsored the "Blades Up Social" an annual event that needs to be experienced. A great time is had by all who attend!

This year's theme "Working in a Winter Wonderland" recognizes the effort operators put forward to serve their agencies throughout the snow and ice season, and to prepare those operators for the upcoming winter season. It really gets you thinking about how prepared your agency is for the upcoming winter season. It seems there are always emerging technologies and a changing workforce. The APWA Western Snow and Ice Conference and National Snow Roadeo is where these questions get answered.



2024 Western Snow & Ice Conference and National Snow Roadeo

Highlights from the event:

- National experts presenting opportunities to expand our knowledge and skillsets.
- Panel discussions with industry leaders holding open and frank conversations about de-icing materials, and snow equipment.
- Discovering ideas creating actionable insights on operational procedures and technologies that attendees could take back to their agency.
- Conversations and ideas sparked between old and new acquaintances bonding peers as they ask questions and answer questions. Networking and creating lasting connections with others in the public works field of snow operations
- National Roadeo had 354 snow operators competing from all over the U.S.

The Opening General Session began with the Windsor High School Choir performing the national anthem and a moving ceremonial flag presentation from Associated Veterans of Loveland. Opening remarks were delivered from Interim Loveland City Manager Rod Wensing, Colorado Chapter President Jay Goldie, and APWA Region IX Director Tina Nelson. The keynote speaker for the general session was Tim Gard. Tim now lives in Portland, Oregon, but was a resident of Denver for over twenty years until recently. He relayed life experiences in a humorous way to help attendees look at many situations from a different perspective and realize there is humor in almost all situations.

Our closing speaker was Rick Nelson, a former District Maintenance Manager for the State of Nevada. Rick has spent a lot of time traveling the world to evaluate snow removal operations and techniques. At the closing, Rick talked about a memorable trip to the Andes Mountains in Argentina and Chile, nearly to Antarctica. Rick also has had a podcast called "Talkin' Winter Ops" for a number of years. Pete Adler and Tim Brady from the Roadeo Committee recorded a podcast with Rick about the conference and roadeo that should be publicly available at all the usual outlets the last week of October.

The best equipment operators across the nation, from Maine to Washington, competed in the National Snow Roadeo. We congratulate each and everyone. (See the list of winners on page 3).

I cannot say how much we enjoy putting this conference together and that we cannot wait until we can do it again in 2025. Please mark your calendars for the 2025 Western Snow and Ice Conference and National Snow Roadeo in Loveland on September 24-26, 2025. The conference planning committee thanks everyone from those sponsoring, presenting, teaching, and attending for making the 2024 conference a success.



Engineering the Future: The Innovation Imperative in Public Works

We in public works are challenged with building resilient infrastructure so our communities can thrive before and after a disruption. For years this has meant approaches like factors of safety, redundancy, and risk registers. But what if ensuring true resilience in today's world requires us to step beyond our comfort zones and embrace uncertainty? What if keeping people safe required taking some risks?

To meet this challenge, we as an industry urgently need to embrace innovation and continuous improvement. While the fundamental laws of physics and math remain constant, this doesn't mean that engineering and public works are immune from change. In fact, it is even more critical for us to evolve than it is for tech giants like Apple or Tesla because we are society's last line of defense for public health and safety.

Look back at history and it's clear: everything we've built can be improved. Things that were once state-of-the-art are now relics of the past, like the Roman aqueducts. Just as the aqueducts evolved into the long-distance pipelines of today, the built environment has continuously changed, often in response to urgent issues like sanitation, natural disasters, and transportation safety. Change often comes from other fields, such as how advances like CAD and strengthened steel have enabled now-common design and construction techniques. Everything was once a new, unproven idea, even the things that are now standards.

Standards, criteria, and guidelines are crucial – they ensure that every project is safe and of high quality. But standards are not the limits of what we can achieve; they're just the starting point. Too often we use the excuse "It's not in the criteria," to avoid the discomfort of change. If standards dictated everything that could be done, our world would stagnate, and that's not a future anyone wants. We as an industry must open our eyes to ideas with potential and start to view standards as a foundation to build on. We must dare to imagine what's possible and not tether ourselves to the past when it doesn't serve us.

Innovative doesn't mean reckless. Safety always comes first, and some areas lend themselves to innovation more than others. But we need to ask ourselves what's truly at risk if we try something new. Sometimes the potential benefits of innovation far outweigh the risks. We must avoid letting fears of unlikely scenarios stifle progress across the board, because missed opportunities can have more severe consequences than trying something new that might not work out. The consequence of failure from testing a new technique is often relatively limited, but if it works, it could benefit the entire industry.

In 1870, a Belgian chemist named Edmund J. DeSmedt laid the first modern asphalt pavement in Newark, New Jersey on a small stretch of road in front of City Hall. There were concerns about the cost and durability of his new alternative to cobblestone and brick. It wasn't in the standards, and it wasn't a huge success, failing relatively quickly. Six years later, DeSmedt applied a refined version of his mixture on Pennsylvania Ave. in Washington D.C. The success and visibility of this project helped spur the widespread adoption of asphalt pavement in America.

Roundabouts, water treatment systems, subways, LED street lighting, and many other established practices in public works can trace their beginnings to pioneering applications where we overcame our fear of the unknown and said yes to trying something new despite our legitimate concerns about the risks.

Emerging technologies like artificial intelligence, robotics, digital twins, decentralized treatment facilities, additive manufacturing, and smart materials – to name a few – have the potential not only to save us valuable time and money by doing old things in new ways, they can also open the door for new people to join our industry and even for entirely new products and solutions we haven't imagined yet.

One of these new people, ideas, or tools might very well hold the key to solving critical challenges like aging infrastructure, sustainability, or workforce shortages. If we turn them away because "It's not in the criteria," we risk losing the one truly limited resource at our disposal to solve these urgent problems: time.

In Remembrance



G.J. (Jerry) Weiss

APWA Colorado sadly recognizes the passing of one of the Colorado Chapter's founding members and Past President, G.J. (Jerry) Weiss.

Mr. Weiss passed away August 14, 2024 at the age of 98. He was born on the family farm near Imperial, Nebraska and grew up during the Great Depression and attended a one-room country school. After graduating from high school he served during World War II in the US Navy as a radio operator on a Destroyer Escort ship in the South Pacific. He graduated from Colorado A&M, now CSU. He was the City Engineer for both the City of Fort Collins and the City of Colorado Springs. He then worked as a consulting engineer for the rest of his professional career.

Jerryenjoyed construction projects which were a major part of his career. He worked on dams, power lines, utility and street construction projects. One of the larger projects he worked on was as Resident Engineer for the construction of the Colorado Springs Airport runways in 1991.

It was during his tenure as Fort Collins City Engineer, that the Colorado-Southern Wyoming Chapter of APWA was organized (1962). Jerry was a Charter Member along with Bill Korbitz, Ted Diefenderfer from Boulder, Merv Miller from Greeley, Jim Murray from Colorado Springs and Sam Ward, Bob Lewis and Gene Lewan from Denver. Eventually the logistics became too difficult for the Wyoming members to attend meetings so it became just the Colorado Chapter. The first annual meeting of the APWA Colorado Chapter was held in Fort Collins in 1963 on the CSU campus. Jerry was elected Colorado Chapter President in 1969 at the previous year's annual meeting.

Jerry renovated two historical houses and researched their history. In retirement, Jerry donated time to build handicap facilities for those in need. He volunteered for many years at Corpus Christi Catholic Church and the John Zay Guest House at Penrose Hospital. He also helped design, plant and maintain the median flower bed sponsored by the Springs in Bloom program in his neighborhood.

We are so grateful for the leadership and support he showed our organization. And we are so lucky he passed that on to his son, Chuck, who is a vital part of our organization today.

A donation was made by the Chapter to the John Zay Guest House at Penrose Hospital.


